



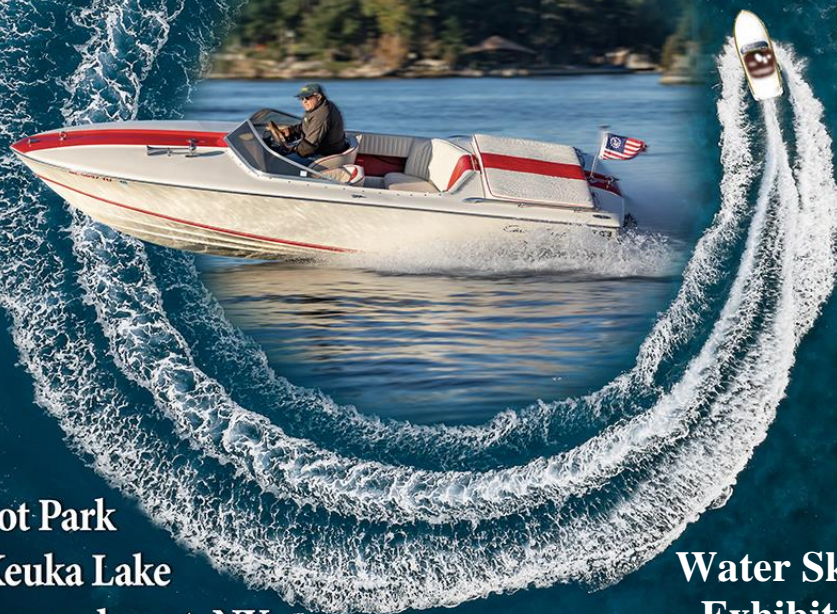

## SHOW EVENTS

### ***Friday, July 15<sup>th</sup>***

#### ***AM Cruise***

This fun cruise will start at 10:00am at Depot Park with a Captains' meeting at 9:30am. The Finger Lakes Boating Museum Pat II will lead this cruise to Snug Harbor at which point she will turn around and return to Depot Park. At this point on the cruise, it will become self-guided at your own pace and lunch will be on your own. Our long-time supporter, The Switzerland Inn (opposite the end of the bluff on the east side) is highly recommended with dockage and outdoor seating. Please pre-register for this event on the registration form (no charge).

#### ***Registration***

Registration packets and placards will be available from 5:00pm – 6:30pm for all pre-registered participants

#### ***Welcome Reception - BYOB***

The Friday evening welcome reception will be held at Depot Park, Hammondsport from 6:00pm – 8:00pm. The reception will be catered by Timber Stone Grill and includes appetizers, pulled pork, rolls, pasta salad with vegetables, green apple coleslaw, mac and cheese, BBQ baked beans, dessert, iced tea, lemonade, and bottled water. The Village and Town have granted us a waiver from their open container laws for this reception so please bring your beverage of choice. We have a maximum number for this event, so please pre-register (cost \$20pp).

### ***Saturday, July 16<sup>th</sup>***

#### ***Boat Show***

- The Boat Show is open from 9:00am – 5:00pm
- Boat Show judging will begin at 10:00am for ACBS Class, WCCB Marque, People's Choice, and Hagerty Youth Judging (ages 7+) awards. It is beneficial if owners are present when the boat is judged
- Boat parade will commence at 3:00pm

#### ***Saturday Evening Dinner***

On Saturday evening, we will be hosting a dinner buffet at the Finger Lakes Boating Museum. The museum is located in the historic former Taylor Wine Company headquarters. Our dinner will be held in Building #9 which holds the museum's row boats. Appetizers and a cash bar with local wines, craft beer, and domestic selections will be available at 6:00pm. The museum's main building will remain open until 6:45pm for participants to enjoy the exhibits throughout its three floors. Dinner will be served at 7:00pm. The buffet style dinner will be catered by Timber Stone Grill and includes salad, sliced NY Sirloin of Beef in a cabernet demi-glace, Boursin Stuffed Chicken, Pistachio Crusted Salmon, roasted seasonal vegetables, herbed fingerling potatoes, and assorted pastries and cakes. We have a maximum number for this event so please pre-register (cost is \$38pp).

After dinner our judges will present this years' Wine Country Classic Boats award winners.

## **Addendum to page 4 of Registration for judging purposes**

### ***Class, Type, & Judging Info 2022:***

For a boat to be judged, it must be in the water under its own power. It should arrive at the dock under its own power unless there is no dock space and/or at the discretion of the chief judge. (as per ACBS judge system guidelines (rev. Feb. 2017).

### ***ACBS Class Categories to be added to page 3 of the Registration Form:***

- Historic: Built before 1919
- Antique: Built between 1919 – 1942 inclusive
- Classic: Built between 1943 – 1975 inclusive (includes fiberglass)
- Late Classic: Built between 1976 – 1996 inclusive (includes fiberglass)
- Contemporary: Built between 1997 – 2022 inclusive (wooden only)

### ***Types of boats to be added to page 3 of the Registration Form:***

- Powered ... launch, runabout, utility (see below) \*\*
- Non-powered
- Cruisers and Commuters
- Outboards and engines
- Fiberglass and non-wood, inboard power
- Non-wood outboard boat and motor
- Non-wood nonpowered
- Outboard boat and motor with steering
- Outboard boat and motor without steering
- Contemporary

### **Please keep the following in mind when you register your boat:**

**\*\*Runabout versus utility** - If the engine is under the deck, it's a runabout. If the engine is under a box it's a utility. Lyman called many of their boats runabouts. For judging purposes it's classified as a utility.

**Preserved versus restored**- Here's the information from the ACBS judging rules:

ACBS defines preserved boats as those containing at least 60% of their original deck and topsides material and are constructed using the same methods and materials as the original. Bottom replacement is expected for the boat to be serviceable, but the method of replacement must duplicate the original. The use of plywood as the inner bottom when not used by the original builder will cause the boat to be classified as restored.

The choice of bedding compound or sealant between the plies of the bottom is immaterial; any suitable material is acceptable in preserved and restored boats — bedding compound and canvas, "5200", epoxy or anything the restorer and owner select. Similarly, the use of plywood underlayment in decks or topsides will also result in the classification of the boat as restored. Boats with less than 60% of their original deck and topsides material or restored using non-traditional methods or materials are defined as restored.

It's easy to find our Show Site. Hammondsport is just off Route 54, which runs along the east side of Keuka Lake (the Y-shaped lake) between Penn Yan and Bath, Route 54 is easily accessible off Interstate 86 (old Route 17). Take Route 54A into the Village of Hammondsport and turn north on Lake Street to Water Street and the Village Park. Launch Ramp is on the west side of the Show Site.
